## **GENERAL CONDITIONS**

### **CANCELLATION POLICY**

If the number minimum of participants is not hit 7 days before the service, it will be cancelled or replaced. In the case of any services cancelled, interrupted or not used by the CLIENT, for whatever reason, the AGENCY has the right to the following compensation, calculated as follows :

- More than 30 days before the event or service: a penalty equal to 50% of the total price
- Less than 30 days before the event or service: a penalty of 100 % of the total price

### **ACTS OF GOD**

It is understood that the term "Acts of God" refers to all events external to the parties which are characterised by being simultaneously unpredictable and unavoidable and which prevent either the client or the participants or the agency or the service suppliers involved in the execution of the project, to carry out part or all of their obligations foreseen by the present agreement and occurring unexpectedly after the signature by the present parties.

By express agreement, this will notably include public disasters, national mourning, strikes covering means of transportation, hotel personnel, air traffic controllers, pilots and navigational personnel, insurrection, riots, epidemics or any type of prohibition dictated by government or public authorities.

It is expressly agreed upon that Acts of God suspend, for both parties, the execution of their reciprocal obligations.

At the same time, each party will bear the burden for all costs for which he is responsible and which result in the occurrence of an Act of God. As a result, the CLIENT will alone bear the additional costs that may be incurred in order to allow for the continuation of the project in the case of an Act of God.

### **PROFESSIONAL CIVIL LIABILITY**

Conforming to the provisions of the Law of 13 Juillet 1992, the AGENCY declares that it has taken out an insurance policy with Cie AXA, represented by the offices of Dupuch located at 30, cours du Chapeau Rouge in Bordeaux, France, which guarantees its Professional Civil Liability. The policy number is 1659725504.

### **CLAIMS POLICY**

Claims should be formulated in the course of the service and addressed to the AGENCY'S representative as soon as it is observed in order to allow the AGENCY to best intervene. If the problem could not be solved, it is up to the CLIENT to address its claim to the AGENCY, by certified mail with a signature required upon reception, no later than 15 days following the end of the service or event in question.

### **ATTRIBUTION OF JURISDICTION**

The CLIENT is forbidden to deal directly with the different service providers researched and selected by the AGENCY on behalf of the CLIENT ;

All disputes arising between the AGENCY and the CLIENT on the subject of the interpretation or the execution of the present contract will be submitted to the TRIBUNAL DE COMMERCE DE BORDEAUX.
